2016 Load Management Program Information

- The Load Management program is limited to those services that can receive the TWACS signal.
- If you are signing up as the land owner, please make sure that your operator or tenant is aware of the program.
- When you sign up for Load Management PREMA needs the following information: operator or tenant and meter number or account number.
- Irrigators with more than three pivots will have pivots split into two groups.
- The Everyday Rate Group will normally be the last group to be controlled when PREMA is in active control status.
- Load Management for 2016 will be limited to the first 400 participants to sign up.

Sign Up

Sign up is **required** again this year for the 2016 Load Management Program.

Tampering

If you are the owner or operator of an irrigation service on which a load control switch is installed, keep in mind you are responsible for making sure no one tampers with the load control switch.

PREMA will be changing out the load control switches. **The new switches will be operated thru the TWACS system with the capability of two-way communication to verify that the switch is operable.**
